- II) The professional competence development of the SHE members and other stakeholders has been supported by the delivery of the SHE support programme.
 - III) The visibility and access to evidence based information on school health promotion has increased by the delivery of SHE publications and presentations.

Methods to achieve these objectives are:

- Set -up a meeting with SHE members and other stakeholders;
- Set-up capacity building workshops;
- Use effectively the SHE website;
- Be available through the SHE helpdesk;
- Share information through newsletters and social media and encourage regional and cross-border cooperation; Support school twinning;
- Develop and implement teacher training material on school health inequality, promote schools and monitor the implementation on school health promotion in Europe.
